SLA outlines three levels of governance and regulation.

DCS Senior Stakeholder Customer Executive Board. Chaired by Dir IGDN(E), the DCS Senior Stakeholder CEB will be held biannually. The board will focus on service delivery against the SLA, performance measurement and risk management in accordance with Key Performance Indicators at Annex A, and compliance and development of additional opportunities through funding options or increasing the overseas footprint. DCS will be required to provide a transparent and objective account of how they have delivered against the agreed baseline for each location. The form of this account should be in written format to demonstrate best practise and kept as part of the audit trail of the governance process.

Location Specific CEB Working Groups (WGs). Chaired by the Local Commander, location-Specific CEB WGs will report risks and issues impacting delivery of DCS education and care services and manage these risks in a timely manner in order to mitigate or elevate to the Senior Stakeholder CEB if required.

School Governance Committees Local Governance Boards. Held at least termly, SGCs have a critical role in providing positive outcomes for pupils in schools by working closely with the Senior Leadership Team (SLT) in agreeing priorities for improvement, ensuring accountability, and monitoring and evaluating school performance. Each individual school and setting should follow School and Settings Governance Board procedures in line with the 'DCS Directive 3.2.14 School Governance Committees TORs (V3.0 2024) and working practices outlined in the National Governance Association guidance 'School Visits' (2023).
